Criteria for Selection

The selected Catholic School leader:

- Is an active leader (or retired no earlier than June 2022) administrator of a Catholic school or diocesan office in New York State,
- Displays a commitment to excellence and is clearly evidenced through programs designed to meet the spiritual, academic, and social-emotional needs of all students and teachers;
- School where administrator is employed or recently retired is a member of the Catholic School Administrators Association of NYS;
- Has a clear philosophy of Catholic education;
- Shows a strong commitment to leadership through active membership in professional associations;
- Is respected by students, colleagues, parents, and the community at large;
- Shows strong educational leadership by setting high expectations for school staff and students.

Evidence of outstanding contributions to the well-being of the educational community include:

- Ways in which the nominee's leadership has benefited Catholic education, curriculum, staff morale, community support, student interest, and /or the learning environment;
- Ways in which the nominee provides creative leadership to inspire others to achieve and contribute to their Catholic education communities;
- Examples of service or achievements above and beyond what is expected;
- Ways in which others have acknowledged the nominee as a force for positive change.
