Just as we promised, here are some activities that proved successful for Catholic Schools Week 1989. Feel free to recycle them in your school for CSW 1990.

- * Holy Cross School in Rochester hosted a "Grandparents' Social" with the preschool. The seniors helped with art classes, attended gym class, used the school's computers and had a party at the end of the day.
- * Our Lady Help of Christians School in Brooklyn reports that even parents whose children have graduated are involved in the CSW activities. The school had a prayer service with the theme "Gifts from the Heart" in which members of the school community were recognized for their unique gifts that make the school a real family.
- * St. Mary's School in Potsdam hosted a family spaghetti supper and featured special T-shirts designed by the school's art teacher. A special assembly offered each class an opportunity to entertain the rest of the school and parents and grandparents.
- * St. Alexander's School in Morrisonville had a Family Olympics on Sunday afternoon. Families ate a picnic lunch in the gym and then formed family teams for a variety of relay races and games that required parents (aunts, uncles, grandparents) working in cooperation with younger children.
- * Sts. Peter & Paul School in Depew had "Friendship Day" in which they ate lunch with someone they hardly knew in order to become better aquainted with another student or teacher. A "Color Day" provided a chance for each grade to choose a color, dress up with it and play "Student Bingo".
- * The parents' club of St. Theodore School in Rochester provided candy apples for "The Apples of their Eye", as a treat to each of the 380 students in the school. A Spirit Day gave students the choice to wear special hats or sneakers and the evening Open House included homemade desserts to "Share the Family Spirit".
- * St. Augustine's School in Peru had a family luncheon after which the students conducted school tours and classroom visits. "Happy Feet Day' gave students the opportunity to show off their favorite footware, sneakers, slippers, dress-up shoes whatever!

On July 27, representatives of CSAANYS, NYSCC and the Superintendents attended the Elementary and Secondary Committee meeting of the Regents. Within a matter of minutes, the Regents approved a document which outlines the minimum standards expected by SED, while recognizing that nonpublic schools are uniquely accountable to parents. On the plus side, not one Regent questioned the performance or the ability to meet or exceed state standards on the part of our schools. Our task is to make clear to the public that we do exactly that; our schools are accountable, not only to SED, but to several other constituencies, whose expectations, we are proud to say, are more than satisfied.

Energy Cycle XII Conservation grants totalling \$9.5 million are available to schools through the Institutional Conservation Program. New this year: there is \$2 million available in supplemental ECM Grant funds for projects in K-12 schools with payback, periods of years. REGENTS SCHOLARSHIPS

The SED has notified us that the 1990 series of scholarships will be awarde on the basis of a combination of grade point average (GPA) and Scholastic Aptitude Test (SAT) scores.

SED has encouraged the development of county-wide plans in order to develop compatability in the computing of GPA's. Accordingly, CSAANYS has sent each board member who represents the high schools a copy of the SED letter and a memo encouraging him/her to apprise each constituency of this plan so that Catholic school concerns are heard.

SED will meet with an advisory group in the Fall to determine guidelines and procedures for submission of GPA's.

REVISED SYLLABUS

The Occupationally Related Math Syllabus was to have been mailed to high schools i August. This course may be used to meet the second unit of Math required for local diploma.

HOW TO SPEND YOUR SUMMER VACATION

Facing the long, hot summer with a less-than-enthusiastic attitude? Here are some tips for

making the most of the summer hiatus while improving your own outlook.

1. Organize your desk (or office). Use a folder system to file all the material that seems to bury your desk. Try having a "5-minute" folder for paperwork that won't take too much time. A priority folder can sort the stuff that needs an answer NOW. A "let George do it" file sorts the items that can be routed to a teacher or the school nurse or anyone else. Finally, the "when I get to it" folder will keep material that you'll take care of when everything else is done - like summer time.

2. Compute. Get all your mandated services and BEDS data together. Either use the new service offered by CSAANYS (see insert), or start putting together your facts and figures now, so that when the BEDS & SA-186 & 185 forms arrive, your secretary can fill them in right away.

3. Read - articles, books, periodicals that you've been saving. Do it on the beach, in the

woods - wherever you can relax and be away from the building.

Travel. Combine it with a summer in-service conference or go to a place where you can visit museums or art galleries or historic sites. In this way you could be a guest speaker for your teachers, while enhancing your own knowledge.

5. Write. Summer's a good time to write some articles for your school's newsletter articles with no time constraints that can be "dropped in" during those busy months when you

need a filler for the newsletter.

6. Contact your teachers for lunch or iced tea break to listen to their hopes and dreams for the coming school year. Interest them in serving on committees or commanding projects so that you won't be stuck doing them, and they'll have plenty of time to think and plan, too.

7. Contact your older students at the end of summer to come in and decorate school hallways and bulletin boards, perhaps help the kindergarten teachers with name tags, etc. This will give them a sense of ownership and excitement about coming back to school, while

establishing a "privilege" reserved to older students.

Plan your school's PR activities for the coming year. Look ahead to the year's activities, Catholic Schools Week (the 1990 theme is Catholic Schools: Parents' Choice). Write some press release outlines, plan photos and various uses of media. Take a good look at your school's promotional material and decide if you need a "new look".

9. Contact your school board members, home-school people and other volunteers just to chat

about the year's program. Get them thinking practically about things they need to do now.

10. Relax and dream about what you'd like to see happen during the coming school year. Jot down ideas gleaned from your summer contacts with teachers, board members, parents, other principals. Check these ideas out in February when the sun isn't shining and rate yourself on

how you're doing at turning dreams into reality.

With September comes the inevitable, "where did the summer go?" as we quickly immerse ourselves in the familiar sea of hectic activity. Perhaps by trying out 2 or 3 of the above suggestions, you'll be able to answer that the summer went toward making September (and October and November...) a little less hectic. Try it; you'll wonder where the year went.

CAN MONEY BUY EDUCATION?

If you listened to radio news throughout the day or caught any of the major networks' evening news broadcasts on Wednesday, May 3, 1989, you heard U.S. Secretary of Education Lauro F. Cavazos call the nation's educational situation, "a disaster we must turn around."

This criticism was based on the results of the annual Federal assessment of student performance. Measures of performance included: graduation rates, SAT scores, teacher salaries, and teacher-student ratios.

The message for NYS did not bode well. The high school graduation rate of 62.9 percent is the 46th lowest in the country. SAT scores dropped 5 points to 889, ranking NY 14th out of the 22 states administering the test.

These are two sobering statistics in a state where the average teacher's salary of \$34,500 is 3rd highest in the nation and the per pupil cost of \$6,497 is only exceeded by laska!

In his press conference, Secretary Cavazos said, "We have not made any progress in the last three years. It's hard to say why. I still believe that we have not focused on the fundamental issues of trying to get everybody involved in the education of children. It's not a matter of dollars."

Here in NYS, we Catholic school supporters can attest to the fact that money does not equal excellence. Our strength is social capital; parents who make sacrifices to send their children to Catholic schools are more inclined to become involved with those schools. We loudly claim this partnership between home and school is important in the work of Catholic education. James Coleman in his research study, Public and Private High Schools concludes that parents of children in Catholic schools form a value and functional community.

*This year we provided a statewide conference which included 18 workshops, three keynotes, 37 exhibitors and the opportunity for parents & principals to share experiences and solutions to problems.

*This past year we represented Catholic schools before both the NYS legislature and the Congress.

*This past year CSAANYS, the only organization of its kind in the country, represented the Catholic schools of NYS to the NYS Education Dept., the NCEA and to local educational agencies.

We urge you to renew now. If you are moving on, please renew for your successor and please spread the word: CSAANYS is the Catholic school administrator's professional organization. It's the only organization that speaks for the administrator on a state-wide level.

State Coordinating Committee

This group met in Albany on March 15. Joseph McTighe reported that prospects are very positive for the inclusion of some monies for asbestos abatement for nonpublic schools. It is the budget deficit, and the subsequent delay (no budget s of April 6), we should not expect to receive the \$25 million we asked for. Legislators contacted by coordinating committee members on the NYSCC lobbying day Jan. 31 were also receptive to our inclusion in the abatement allocation. The next Coordinating Committee meeting is in New York City on May 10.
