### Health Services. Excise Tax. 15 mile Bus Mandate Signed.

Monday, June 10 - Gov. Malcolm Wilson signed into law today three bills at removing practices which discriminated against our students. The object of these bills is to insure that equitable health services are rendered to all nonpublic students, that our schools will receive the same excise tax exemption as public schools for motor fuel, and the "in district-out of district" interpretation can'no longer be used as a basis for inequitable treatment in transportation. This last law, because of date of application being past, will be permissive, not mandatory, for the coming year.

As of this writing, the fire alarm transmission bill and the TAP bill are still

### **Budget and Membership Reports Prepared**

A detailed budget report on 73-74 will be mailed to all members in July, as well as an up-to-the-minute membership report. There are several weeks before the end of the fiscal year, and much can change in that time. Our present condition can be summed up in several statements:

- \* Actual expenditures were lower than the projected budget figures.
- \*Dues actually received have been insufficient to meet current obligations.
- \* Prompt payment of renewals would have allowed us to meet all running expenses for the current year, but new memberships are needed to pay back loans taken last summer on promised memberships to cover 72-73 expenses.

Memberships have started to come in fast since June 1, and if even half of the non-member principals as of that date join, we will have little trouble in meeting all our obligations in the coming year.

The Executive Board decided at the May meeting that since CSAANYS has two years and many accomplishments to its credit, the membership figures of next January must be taken as the realization of our practical potential. Therefore a review of the financial situation, with an eye towards expanding or decreasing staff and services, must be made in January so that any changes in arrangements can be accomplished with due notice to the individuals and congregations involved.

Our hope is that a near 100 per cent membership will allow us to add staff and serve administrators in more ways.

Among the goals discussed at our May meeting for consideration in July were: Service

- \* represent principals in disputes with school districts over textbooks, busing and Title I planning.
- \* facilitate sharing of experience of developments in curricula and administration.
- \* act as a resource for administrators in questions about lunch programs, Title programs, health programs, insurance, etc., etc.
- \* develop legislative programs that will achieve equity for our students.

#### Communication

- \* maintain and improve the grassroots nature of CSAANYS by local meetings.
- \* maintain our liaison with the Federation of Catholic School Parents, SAANYS, NCEA, as well as with the State Ed. Detp., etc.
- \* relate to media the achievements of Catholic schools.
- \* relate to the public the philosphy and history of religiously oriented schools as part of American history and values.

### **NEWSBRIEFS**

#### TEXTBOOK LAW

The SED is gearing up to notify districts and make new provisions of the law operative. Schools that have not had to place order as yet, should be able to order lab books, etc. (We tried to get law passed much earlier.) In past years many districts spent only a fraction of the state money allowed them. The K-6 program may change that. However, if money is available after the initial ordering, all students should share in it.

#### SCHOOL LIBRARIES

As of February 18th, 1974, all schools in the state must maintain a library.



#### Msgr. Charles Eckermann

Acting on the conviction that a new organization such as CSAANYS should not be too long guided by one hand, Msgr. Charles Eckermann, principal of Bishop Ludden H.S., Syracuse, announced at the March board meeting that he did not wish to stand for re-election as the chairman nor as the secondary representative from Syracuse.

Respecting his judgment and good intentions, the board regretfully acceded to his wishes, saying that they would miss his professional advice and direction at their meetings. He was one of the dozen or so principals responsible for CSAANYS coming into existence, and no one had a clearer vision of needs and directions for CSAANYS, nor a greater desire to make it succeed through hard work and personal sacrifice.

The Board Members applauded his intention of working closely with and for CSAANYS. It is their hope that he will long be in the work of the schools, for Catholic education can ill afford to lose the services of such a gifted man.

Elementary schools are for the first time being specifically brought under the requirements of law in this matter.

#### TITLE I ALLOCATIONS

The battle over a new formula for Title I allocations still rages between the House, Senate, and White House. The Senate is trying to restore to large cities monies they would lose in the House version. The final outcome is not predictable, but it should be known sometime during the summer. State priorities on reading, math, and bi-lingual education will apply again next year. Administrators should have ideas and needs ready to present for suitable programs in September.

The study guide on freedom of religion in education in the light of the First Amendment will be printed during the summer. Descriptive material and order forms for teachers who want a copy mailed directly to them during the summer are being sent to principals.
